3	Resolution proclaiming June 24, 2010, as Elizabeth Rojas-Colville Day in the City and
4	County of San Francisco.

6	WHEREAS, the San Francisco Board of Supervisors recognizes and honors the vital
7	role that Ms. Colville has played as a dedicated champion and tireless advocate of
8	reproductive and health during her career at the San Francisco Department of Public Health
9	for the last 24 years; and
10	WHEREAS, Ms. Colville kept San Francisco's young people safe from HIV infection in
11	the early days of the AIDS epidemic by co-authoring a "Family Life Education Curriculum for
12	Incarcerated Youth" and by conducting family life, STD and HIV prevention education and
13	outreach to Spanish-speaking, Latinos and others residing in the Mission District and
14	throughout the city and county; and,
15	WHEREAS, Ms. Colville played in instrumental role in developing and piloting the
16	Wedge, a collaborative SFDPH and SFUSD program that was the first in the U.S. to make
17	HIV-positive speakers the focus of a comprehensive HIV prevention education effort; and as
18	she served as interim Director during a crucial transition phase of this program; and
19	WHEREAS, Ms. Colville was a pioneer in recognizing the risk that HIV posed to
20	women, establishing one of the first club outreach efforts to target women with HIV education
21	and condom distribution between 1986-1988; and founding one of the first programs to
22	integrate HIV testing into Family Planning programs in 1986; and
23	WHEREAS, Ms. Colville brought her professionalism, leadership, dedication and
24	experience to serve as the Director for Family Planning and Preconception Health in the

SFDPH Maternal, Child and Adolescent Health (MCAH) Section for the last eleven years; and
