3 **Ordinance amending the Fiscal Year 2006-2007 Annual Appropriation Ordinance by**  
4 **adding Section 30.7, to appropriate revenues collected from special assessments for**  
5 **disbursement to the respective nonprofit owners' associations for administration of the**  
6 **three property and/or business-based business improvement districts established in**  
7 **San Francisco during Fiscal Year 2006-2007 (i.e., the Fillmore Jazz, Central Market, and**  
8 **Fisherman's Wharf Portside Community Benefit Districts), for authorized purposes.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Ordinance No. 202-06, the Consolidated Budget and Annual Appropriation  
15 Ordinance appropriating all estimated receipts and all estimated expenditures for the City and  
16 County of San Francisco for fiscal year ending June 30, 2007, is hereby amended by adding  
17 Section 30.7, to read as follows:

18 Sec. 30.7 Business Improvement Districts Established During Fiscal Year 2006-2007 – the  
19 Fillmore Jazz, Central Market, and Fisherman's Wharf Portside Community Benefit Districts.  
20 Proceeds from all special assessments levied on real property and businesses included in the property  
21 and/or business-based business improvement districts in the City and County of San Francisco are  
22 hereby appropriated for the fiscal year ending June 30, 2007 in the respective amounts actually  
23 received by the City and County in such fiscal year for each such district. The Controller is authorized  
24 to disburse the assessment revenues appropriated by this section to the respective owners' associations  
25 (as defined in Section 36614.5 of the Streets and Highways Code) for such districts as provided in the

1 management district plans, resolutions establishing the districts, annual budgets and management  
 2 agreements, as approved by the Board of Supervisors for each such district, for the purposes  
 3 authorized therein, as follows:

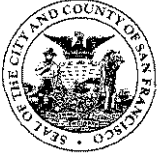


