11 Kevin Dole, seat 1, succeeding himself, term expiring on November 19, 2014, must be
12 a nominee of the District 1 Supervisor, to serve a two-year term ending November 19, 2016,
13 or for the tenure of the nominating Supervisor, whichever is shorter in duration.

14 Winston Parsons, seat 2, succeeding Richard Tilles, resigned, must be a nominee of
15 the District 2 Supervisor, to serve a two-year term ending November 19, 2016, or for the
16 tenure of the nominating Supervisor, whichever is shorter in duration.

17 Edward Nicolson, seat 4, succeeding himself, term expiring on November 19, 2014,
18 must be a nominee of the District 4 Supervisor, to serve a two-year term ending November
19 19, 2016, or for the tenure of the nominating Supervisor, whichever is shorter in duration.

20 Morgan Fitzgibbons, seat 5, succeeding himself, term expiring on November 19, 2014,
21 must be a nominee of the District 5 Supervisor, to serve a two-year term ending November
22 19, 2016, or for the tenure of the nominating Supervisor, whichever is shorter in duration.

23 Richard May, seat 6, succeeding himself, term expired, must be a nominee of the
24 District 6 Supervisor, to serve a two-year term ending November 19, 2016, or for the tenure of
25 the nominating Supervisor, whichever is shorter in duration.
