6 was founded by Peter Dwares in 1998; and,

7 WHEREAS, Pathways for Kids provides mentorship to at risk high  
8 school students by matching students with successful entrepreneurs  
9 and professionals; and,

10 WHEREAS, Through a mentoring relationship with a successful  
11 business leader, participating students are exposed to a positive  
12 role model and gain insight into worlds they may never have dreamed  
13 existed; and,

14 WHEREAS, While some at risk youth may not want to stay in  
15 school, the Pathways program can help them understand the relevance  
16 of an education to their future; and,

17 WHEREAS, Pathways participants sign on for a minimum of nine  
18 months during which time mentor and mentee meet twice per month at  
19 the mentor's place of business; and,

20 WHEREAS, Pathways gives both mentors and mentees a way to  
21 channel their positive energies; and,

22 WHEREAS, Pathways for Kids successfully served 10 kids in the  
23 Fall of 1999, will serve another 45 this year, and plans to serve  
24 close to 600 by 2004; now, therefore, be it


