3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine public**  
4 **premises license to Tiffany M. Pisoni for Wines of California wine bar, located at Pier**  
5 **39, Space N213A (District 3), will serve the public convenience and necessity of the**  
6 **people of the City and County of San Francisco, in accordance with Section 23958.4 of**  
7 **the California Business and Professions Code, with conditions.**

10 WHEREAS, Tiffany M. Pisoni is seeking the issuance of a Type 42 on-sale beer  
11 and wine public premises license for Wines of California wine bar, located at Pier 39,  
12 Space N213A (District 3); and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
20 on-sale beer and wine public premises license to Tiffany M. Pisoni for Wines of  
21 California wine bar, located at Pier 39, Space N213A, will serve the public convenience  
22 and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) The sales, service, and consumption of alcoholic beverages shall  
24 be permitted only between the hours of 11:00 a.m. and 10:00 p.m. each day of the  
25 week. (2) No noise shall be audible beyond the area under the control of the

1 licensee(s). (3) No person under the age of twenty-one (21 years of age) shall sell,  
2 furnish, or deliver alcoholic beverages. (4) There shall be no coin operated games or  
3 video machines maintained upon the premises at any time. (5) Loitering (loitering is  
4 defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on  
5 any sidewalks or property adjacent to the licensed premises under the control of the  
6 licensee. (6) The petitioners shall be responsible for maintaining free of litter the area  
7 adjacent to the premises over which they have control. (7) Graffiti shall be removed  
8 from the premises and all parking lots under the control of the licensee within 72 hours  
9 of application. If the graffiti occurs on a Friday or weekend day, or on a holiday, the  
10 licensee shall remove the graffiti within 72 hours following the beginning of the next  
11 weekday. (8) The interior lighting maintained therein shall be sufficient to make easily  
12 discernible the appearance and conduct of all persons and patrons in that portion of the  
13 premises where alcoholic beverages are sold, served, delivered or consumed. (9) The  
14 exterior of the premises shall be equipped with lighting of sufficient power to illuminate  
15 and make easily discernible the appearance and conduct of all persons on or about the  
16 premises. Additionally, the position of such lighting shall not disturb the normal privacy  
17 and use of any neighboring residences. (10) No person under the age of 21 shall enter  
18 or remain in these public premises.


