3 **Ordinance authorizing settlement of the lawsuit filed by Phris M. Keaton against the**
4 **City and County of San Francisco for \$45,000; the lawsuit was filed on April 21, 2021, in**
5 **San Francisco Superior Court, Case No. CGC-21-591264; entitled Phris M. Keaton v.**
6 **Garret Edwards, et al.; the lawsuit involves alleged personal injury due to excessive**
7 **force by Sheriff’s Deputy.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Phris M. Keaton v. Garret Edwards, et
12 al, San Francisco Superior Court, Case No. CGC-21-591264 by the payment of \$45,000. The
13 lawsuit involves alleged personal injury due to excessive force by Sheriff’s Deputy.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April
15 21, 2021, and the following parties were named in the lawsuit: Phris M. Keaton, Plaintiff;
16 Garret Edwards, San Francisco Sheriff’s Office, City and County of San Francisco,
