Resolution authorizing the nullification of the current four Priority Conservation Areas: Sutro Tower, Aquavista/Twin Peaks, Palou/Phelphs Open Space, and Bayview Radio Property and allowing the Planning Department to further study the topic in order for the Board of Supervisors to consider new designations at a later date that align more closely with the policies and goals adopted by the City.

WHEREAS, The Association of Bay Area Governments has designated four areas as "Priority Conservation Areas" in San Francisco; and

WHEREAS, The four Priority Conservation Areas, locally identified locations in urgent need of preservation, were designated in 2007, and are: 1) Sutro Tower, 2) Aquavista/Twin Peaks, 3) Palou/Phelps Open Space, and 4) Bayview Radio Property, with a map of the areas on file with the Clerk of the Board; and

WHEREAS, The City and County of San Francisco did not nominate the original designation of Priority Conservation Areas; and


WHEREAS, the Association of Bay Area Governments has notified the City and County of San Francisco that new nominations for Priority Conservation Areas (hereinafter "PCA") may only be submitted if the current nominated PCAs are nullified; and

WHEREAS, To nullify the current designations, the Association of Bay Area Governments guidelines state that a formal resolution of nullification must adopted by the jurisdiction.

WHEREAS, The Association of Bay Area Governments has established December 10, 2014 as the deadline for nullification resolutions and has established the nomination deadline for new Priority Conservation Areas as May 30, 2015; now, therefore, be it

RESOLVED, That the 1) Sutro Tower, 2) Aquavista/Twin Peaks, 3) Palou/Phelps Open Space, and 4) Bayview Radio Property PCAs be nullified; and, be it

FURTHER RESOLVED, That the San Francisco Planning Department is authorized to study and select new Priority Conservation Areas, to be brought forward to the Board of Supervisors by May 30, 3015.
