[Agreement For Tolling of Statute of Limitations Governing Lawsuit]

Resolution approving the City Attorney's entry into a tolling agreement governing suit by plaintiff Natasha Madaris entitled Natasha Madaris v. San Francisco Unified School District and City and County of San Francisco, Case No. 417-848.

WHEREAS, plaintiff Natasha Madaris has filed a wrongful death action against the City and County of San Francisco; and

WHEREAS, plaintiff now wishes to dismiss this action as against the City and County of San Francisco without prejudice; and

WHEREAS, if plaintiff were to re-name the City and County of San Francisco as a defendant in this action during its pendency, the City and County of San Francisco might have a viable statute of limitations defense; and

WHEREAS, the City Attorney of the City and County of San Francisco has recommended that the City enter into an agreement by which plaintiff would dismiss her claims against the City and County of San Francisco in exchange for the City and County of San Francisco's agreement to toll the statute of limitations governing plaintiff's claims against the City and County of San Francisco during the pendency of the aforementioned action (the "Dismissal Agreement"), effective on the date the parties sign the agreement; now, therefore, be it






