3 **Ordinance authorizing settlement of the lawsuit filed by Sandra Hernandez, Clarisse**
4 **Hernandez, Diego Hernandez, and David Hernandez against the City and County of San**
5 **Francisco for \$214,000; the lawsuit was filed on June 7, 2017, in San Francisco**
6 **Superior Court, Case No. CGC-17-559385; entitled Sandra Hernandez, et al. v. City and**
7 **County of San Francisco, et al.; the lawsuit involves alleged personal injury from**
8 **collision with City vehicle.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Sandra Hernandez, et al. v. City and
13 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-17-559385 by
14 the payment of \$214,000. The lawsuit involves alleged personal injury from collision with City
15 vehicle.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 June 7, 2017, and the following parties were named in the lawsuit: Plaintiffs Sandra
18 Hernandez, Clarisse Hernandez, Diego Hernandez, David Hernandez; Defendants City and
19 County of San Francisco, Purveen Kumar Joshi.
