Hi Greg,

I hope all is well. I spoke with Lily and she suggested I connect with you. we have a bit of an unusual situation and we need to A&E \$1m from the state.

Background:

In the State budget bill (SB105), a \$1m earmark was included for Chinese Hospital for an oncology center. However, that bill states the money needs to be paid to the City as a pass through. So, what we need to do is an A&E to appropriate the money from the state. Once done, the Contracts team can certify a grant between DPH and Chinese Hospital.

The weird part is that I don't have much documentation as this is a budgetary earmark and not a formal state grant with associated terms etc. The attached document is what DHCS wants the City to sign. Beyond that, the only thing I have to offer is the legislation SB105 itself that states the money is for an oncology center at Chinese hospital but has to be paid to us instead of Chinese Hospital directly.

Can we connect and figure out how we get an A&E going? Can we find time next week? We have eyes on this one and could use your help getting it moving.
