I checked with our team. The spending plan agreed to with the Sheriff's Office to bring them into budget does not include any additional current year (before June 30th) academy classes. But I hope the department's budget for the new year would include them – as discussed, the department's overtime trends clearly indicate a need to bring more staff on board. But absent additional appropriations from the Mayor and Board in the current year, my office has no authority to increase staffing levels on our own.

Notes:

controllers are not in the approval path of hiring

only exception is when the dept goes above there budget

only 4 depts currently are in the Controllers approval path

they do that when depts are over budget

Controller needs a plan from the dept to get back into budgeted levels, when over budget

SFS0 - failure was over spending, got to ok levels in dec

at the moment Controller is not holding up sheriff hires, as long as they are in budgetted levels

all the sheriff office needs is to show plan to get back to budgeted levels

as long as his current budget supports the hiring and at bugetted levels we will approve them

mayor and board needs appropriate more money for it

Ben will get hiring plan to me that shows getting sheriff getting to budgeted level

Ben agrees we need more people

Ben said 25% hours worked of sheriffs are in overtime, that doesnt make financial sense

We produced an audit a couple years ago in 2019, Ben continues to believe all that holds true today
