4 **Resolution authorizing the Department of Public Health to retroactively accept and**
5 **expend a grant in the amount of \$16,876 from the University of California San**
6 **Francisco to participate in a program entitled “Western States Node of the National**
7 **Drug Abuse Treatment Clinical Trials Network” for the period of September 1, 2010,**
8 **through August 31, 2011.**

10 WHEREAS, UCSF is the recipient of a grant award from the National Institutes of
11 Health supporting the Western States Node of the National Drug Abuse Treatment Clinical
12 Trials Network; and,

13 WHEREAS, With a portion of these funds, UCSF has subcontracted with DPH in the
14 amount of \$16,876 for the period of September 1, 2010 through August 31, 2011; and,

15 WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to
16 enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk of the
17 Board of Supervisors in File No.110127; which is hereby declared to be a part of this
18 resolution as if set forth fully herein; and,

19 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
20 for one existing position, one Senior Physician Specialist (Job Class 2232) at .05 FTE, for the
21 period of September 1, 2010 through August 31, 2011; and,

22 WHEREAS, A request for retroactive approval is being sought because DPH did not
23 receive notification of the contract until December 13, 2010 for a project start date of
24 September 1, 2010; and,

1 WHEREAS, The budget includes a provision for indirect costs in the amount of \$1,808;
2 now, therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively
4 in the amount of \$16,876 from UCSF; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
7 be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
9 agreement on behalf of the City.


