2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF-SALE  
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 310 BAYSHORE  
4 BOULEVARD TO 1546 MARKET STREET TO PEI XIA FUNG FOR VARIETY  
5 CONVENIENCE STORE WILL SERVE THE PUBLIC CONVENIENCE AND  
6 NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO,  
7 IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND  
8 PROFESSIONS CODE; WITH CONDITIONS.

10 WHEREAS, Pei Xia Fung is seeking transfer of a Type 21 off-sale general  
11 alcoholic beverage control license for Variety Convenience Store located at 1546  
12 Market Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 310 Bayshore Boulevard to  
21 1546 Market Street for Pei Xia Fung for Variety Convenience Store, will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) No wine shall be sold with an alcoholic content greater than 15%  
24 by volume. 2) No beer products shall be sold in less than six pack quantities per sale. 3)

1 Wine shall not be sold in bottles or containers smaller than 750 ml, and wine coolers  
2 shall not be sold in units of less than a four pack.




