

1 [Lease Agreement]

2 **Resolution authorizing and approving lease of City-owned property located on the**  
3 **first floor of the Civic Center Courthouse, 400 McAllister Street, to the Northern**  
4 **California Service League.**

6 WHEREAS, The Northern California Service League is a non-profit corporation which  
7 has provided a Children's Waiting Room in Room 111 which provides a positive  
8 environment for children whose parents have business with the Courts since 1998; now,  
9 therefore, be it

11 RESOLVED, That in accordance with the recommendation of the City Administrator  
12 and the Director of Property, the Director of Property is hereby authorized to take all actions,  
13 on behalf of the City and County of San Francisco, as Landlord, to execute a one year lease  
14 with nine (9) one year options to extend with the Northern California Service League for  
15 rental space located on the first floor, commonly known as Room 111 of the Civic Center  
16 Courthouse, 400 McAllister Street for a Children's Waiting Room; and, be it



18 FURTHER RESOLVED, The proposed use provides a public benefit and as such, the  
19 rental of said property is established at One (\$1) Dollar per year; and, be it



21 FURTHER RESOLVED, The lease shall include a provision in which the City  
22 indemnifies, defends, and holds harmless the Lessees from and against any and all claims  
23 or liability for any injury or damages any person or property occurring as a result of City's  
24 acts or omissions or any default by City in the performance of its obligations under the  
25 leases. Said leases shall be in a form approved by the City Attorney; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of  
2 Property to enter into any amendments or modifications to the Lease (including without  
3 limitation, the exhibits) that the Director of Property determines, in consultation with the City  
4 Attorney, are in the best interest of the City, do not increase the rent or otherwise materially  
5 increase the obligations or liabilities of the City, are necessary or advisable to effectuate the  
6 purposes of the Lease or this resolution, and are in compliance with all applicable laws,  
7 including City's Charter.




