16 Agreement concerning the City's 2002-2003 budget which provides: (a) for the City to reduce
17 its "pick-up" of the required employee contribution to the retirement system by 2.75% of the
18 employees' compensation effective July 1, 2002 through June 30, 2003; (b) a 1% base wage
19 increase effective close of business June 30, 2003 and; (c) a no layoff commitment in fiscal
20 year 2002-2003 for employees represented by participating employee organizations.

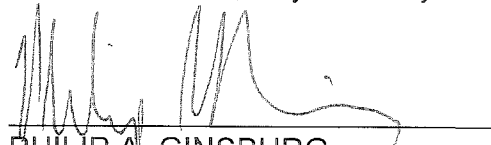

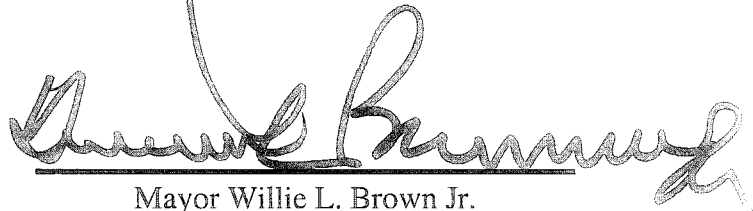
