10 the leather/alternative lifestyle, highlighting entertainment, service and vendors; and,

12 WHEREAS, Proceeds from the production of the fairs are distributed to organizations
13 which promote a sense of community, diversity, cooperation, health and human services;

16 WHEREAS, At the Folsom Street Fair 2000, SMMILE collected \$265,000 in donations
17 that were distributed to organizations such as Healing Waters; the Gay, Lesbian, Bisexual,
18 Transgender Historical Society; Tenderloin AIDS Resource Center; Asian & Pacific Islander
19 Wellness Center; Maitri: Residential Care for People Living with AIDS; Bay Area Young
20 Positives; Episcopal Community Services of San Francisco; and Pets Are Wonderful Support;

23 WHEREAS, SMMILE-produced street fairs not only benefit these organizations but
24 add to the dynamic social fabric of the city and attract thousands of visitors to San Francisco
