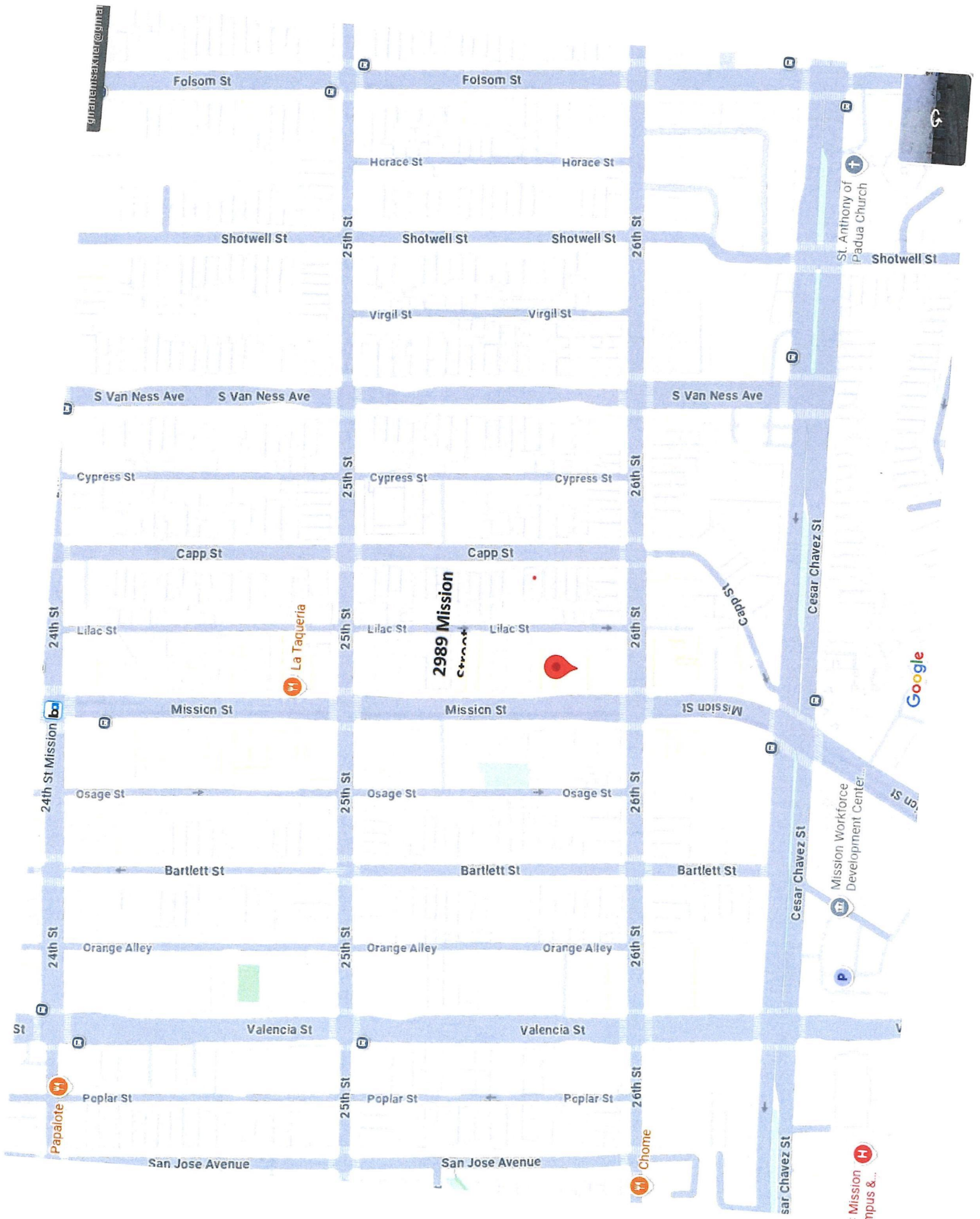
1. (1) Except as provided in Condition 2 below, no noise shall be audible beyond the area under the control of the licensee. (SF district office only).

(2) Any noise caused by entertainment or amplified sound that is subject to the provisions of an active Entertainment Permit issued by the San Francisco Entertainment Commission shall be authorized in accordance with the limits established by that Entertainment Permit, including any limitation on hours during which entertainment or amplified sound is permitted. A violation of the entertainment or amplified sound noise conditions of the Entertainment Permit, as determined by the San Francisco Entertainment Commission (or any successor agency), shall be deemed to be a violation of this Condition. Any noise that is not subject to, or is beyond the scope of, the Entertainment Permit shall be subject to Condition 1 above. "Entertainment Permit" means any of the following: a Just Add Music permit, a Limited Live Performance permit, a Place of Entertainment permit, a Fixed Place Amplified Sound permit, or any similar such permit issued by the San Francisco Entertainment Commission. (SF district office only)

2. Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on ABC-257.

3. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control, as depicted on ABC-257.

4. At any time, the premise is providing live entertainment, the petitioner(s) shall have two (2) uniformed security guard(s) on the premises and shall maintain order therein to prevent any activity which would interfere with the quiet enjoyment of their nearby residents, or the surrounding community. The uniform security guards must be licensed by the State of California Department of Consumer Affairs.

The purpose of this letter is to respectfully request to be placed on the Board's PSNS Subcommittee calendar for Public Convenience and Necessity review for our Type 90 ABC license.

Endgames improv has operated in San Francisco for more than 15 years; we are a training center and live entertainment venue. With the continued struggles of local theaters and almost every other small theater requiring donations to stay open, theaters need every lifeline we can get.

Endgames stands out as one of the few arts organizations focused on permanent spaces without needing donations or catering to a wealthy clientele. We have 100% financial aid for classes and to my knowledge have not turned anyone down who sincerely requested.

The premises are underutilized at the moment, as we are not a competitive venue for talent to perform without the option of alcohol in the evening. We are uniquely set up to develop new talent based right here in San Francisco, but we need a proper nightlife environment to be able to keep them as they become more polished.

Our primary focus is theater, comedy, and art. These activities are not known to bring crime to an area. When services are provided to community members, it gives folks a place to congregate constructively. In addition, we are going to make certain that alcohol is not the sole focus of our menu. Non-alcoholic options will be available and encouraged.

This request helps a part of San Francisco arts survive. Too often full bars are in control of the local entertainment scene as they allow only the shows that bring in drinkers to perform. Endgames is arts first, with only 10% of our revenue coming from liquor sales in the first year of having a license at our other space.

Last year, we started a yearly comedy festival that will be hosted again in September. Activating our second location enables more performances for more names and audiences coming through town.

We appreciate your consideration of our Type 90 Live Entertainment Venue alcohol license and look forward to many more years of operating in San Francisco.
