3 **Resolution approving the Fifth Amendment to the Agreement between the City and**
4 **County of San Francisco (Purchaser) and Sunset Scavenger Company (Contractor) for**

8 WHEREAS, The Purchaser entered into an Agreement with Contractor, dated
9 December 6, 2001, to procure hauling services of sludge, grit and other waste materials, as
10 amended by the First Amendment dated December 12, 2003, the Second Amendment dated
11 December 19, 2005, the Third Amendment dated June 13, 2006, and the Fourth Amendment
12 dated October 31st, 2006; and,

13 WHEREAS, The Purchaser and Contractor propose to enter into a Fifth Amendment to
14 the Agreement to increase the total compensation under the contract to an amount not to
15 exceed \$10,650,000 and San Francisco Charter Section 9.118(b) provides that agreements
16 entered into by a department, board or commission requiring anticipated expenditures by the
17 City and County of ten million dollars, shall be subject to approval of the Board of Supervisors
18 by resolution; and,

19 WHEREAS, The Agreement and the proposed Fifth Amendment are on file with the
20 Clerk of the Board of Supervisors in File No. 061475, which are hereby declared to be a part
21 of this resolution as if set forth fully herein; now, therefore, be it

22 RESOLVED, That the Board of Supervisors approves the Fifth Amendment to the
23 Agreement.




