

**FIRST AMENDMENT TO JOINT EXERCISE OF POWERS AGREEMENT BETWEEN THE
CITY AND COUNTY OF SAN FRANCISCO, THE CITY OF BRISBANE, AND THE
GUADALUPE VALLEY MUNICIPAL IMPROVEMENT DISTRICT**

THIS FIRST AMENDMENT (Amendment) to the Joint Exercise of Powers Agreement Between the City and County of San Francisco, the City of Brisbane, and the Guadalupe Valley Municipal Improvement District (Agreement) is entered into as of June ___, 2026, by and between the City and County of San Francisco, acting by and through its Public Utilities Commission (SFPUC), the City of Brisbane (Brisbane), and the Guadalupe Valley Municipal Improvement District (District) (Brisbane and District are collectively referred to as Brisbane/District).

Recitals

- A. Pursuant to the Agreement, included as **Exhibit A**, the SFPUC provides wastewater treatment and disposal services to Brisbane and District for dischargers within their service areas; and
- B. Brisbane/District's wastewater discharges are collected by their wastewater facilities which then enter SFPUC's combined wastewater sewer system for treatment and disposal; and
- C. The Agreement had a term of 30 years, beginning on July 31, 1995 and expiring on July 31, 2025; and
- D. The parties are continuing to operate under the terms and conditions of the Agreement; and
- E. The parties are currently negotiating a new long-term agreement, including potential changes to wastewater and treatment disposal service rates and regulatory compliance requirements and procedures; and
- F. To ensure continuity of service, SFPUC and Brisbane/District desire to extend the term of the Agreement until a new agreement is reached.

NOW, THEREFORE, the parties agree as follows:

- 1. **Term:** The term of the Agreement is retroactively extended until the earlier of December 31, 2027, or when a new long-term agreement is executed by the parties.
- 2. **Other Agreement Terms:** All other terms of the Agreement remain unchanged and in full force and effect.
