Dear Clerk Stephanie Cabrera,

We would like to submit the following public comment for the Behavioral Health Committee Meeting tomorrow, July 28th:

“ Behavioral Health case managers carry a case load of our city’s most challenging residents. They are working with clients who have pervasive mental illness often coupled with substance use. The work they do is nothing short of exceptional. They are working up against a broken system - no access to 24hr shelter beds, no access to same day treatment, limited access to 24hr crisis centers, and not enough acute inpatient psych beds in the city.

We are emergency room social workers in one of the busiest emergency rooms in the city. We often interface with behavioral health case managers when their clients come through the ED. More often than not, due to challenges mentioned above, we are left with the only option to send the client right back out into the same situation.

Behavioral health clinicians are underpaid, overworked, under trained and left to fight an uphill battle for their client case load. The city needs to do better. If we want to change the current landscape of this city, we need to invest in the resources that are most dedicated to helping those in need. ”

Re: July 28, 2023 Hearing before the Homelessness and Behavioral Health Committee

Dear Supervisors Ronen, Walton, Mandelman and mostly SFDPH:

I am interested in the July 28 hearing because I advocate for the homeless, particularly senior homeless. Could you please ask DPH:

How much is their case management system directed to the homeless on the street and within shelters and navigation centers? How is this accomplished, through pro-active outreach on the street or within shelters or waiting around behavioral health clinics for agencies to refer the homeless to them or homeless people to show up? It is unclear to me. Do/Will they have anything within their strategic and action plans now or in the future regarding case management (particularly intensive case management) for the street/shelter/center homeless? What are their plans for cooperating/coordinating with HSH?

Any help you can provide to get answers to these questions would be greatly appreciated.
