10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by Section
12 Sections 10.25-10 and 10.25-11 to read as follows:

13 **Sec. 10.25-10. AIRPORTS COMMISSION LEGAL PROCEEDINGS.**

14 Notwithstanding any other provision of the Administrative Code, the Airports
15 Commission is authorized to settle, dismiss or compromise any legal proceeding, including,
16 but not limited to, any litigation or adjudicatory or enforcement proceeding before a court,
17 administrative body, federal, State or local enforcement body, hearing officer or arbitrator,
18 brought for or against the City which involves: ~~(1) any airport construction contract; or (2) any~~
19 ~~property or matter under the jurisdiction of the Airports Commission unrelated to a construction~~
20 ~~contract~~ in which the total monetary amount, if any, does not exceed \$100,000, but only upon
21 the recommendation of the City Attorney.

22 **SEC. 10.25-11. AIRPORTS COMMISSION UNLITIGATED CLAIMS.**

23 Notwithstanding any other provision of the Administrative ~~code~~Code, the City
24 Attorney, with the consent of the Airports Commission, is authorized to settle, dismiss or
25 compromise unlitigated claims or demands which involve: ~~(1) any airport construction contract;~~

1 ~~or (2)~~ any property or matter ~~unrelated to a construction contract~~ under the jurisdiction of the
2 Airport Commission in which the total monetary amount, if any, does not exceed \$100,000.




