3 **Resolution honoring Amy L. Brown and proclaiming January 6, 2012, to be as “Amy L.**  
4 **Brown Day” in the City and County of San Francisco.**

6 WHEREAS, After over twelve years of public service working for the City and County  
7 of San Francisco, Amy L. Brown will be leaving office as Acting City Administrator on January  
8 6, 2012 to accept the position of City Manager of the City of Campbell, California; and

9 WHEREAS, Amy L. Brown, as Deputy City Attorney from 1999 to 2006, negotiated  
10 and drafted a variety of complex transactions to benefit the City for years to come; and

11 WHEREAS, During her tenure as Real Estate Director from 2006-2011, Amy L. Brown  
12 oversaw the phenomenal and successful 1500% growth of the Real Estate Department to  
13 servicing today over 50 buildings across the community; and

14 WHEREAS, After assuming the additional role of Deputy City Administrator in 2008,  
15 Amy L. Brown was instrumental in orchestrating the training and deployment of over 200  
16 Volunteer Commissioners to perform same-sex marriages during the summer of 2008; and

17 WHEREAS, As Deputy City Administrator, Amy L. Brown brought renewed focus to  
18 the City’s disaster recovery planning efforts, improvements to Moscone Center and planning  
19 for its expansion, as well as enhanced community engagement through the Neighborhood  
20 Empowerment Network; and

21 WHEREAS, Upon her appointment as Acting City Administrator by Mayor Edwin M.  
22 Lee on January 11, 2011, Amy L. Brown served this past year leading the General Services  
23 Agency of over 2200 employees and a budget of more than \$200 million with distinction,  
24 guided by her unwavering professionalism and integrity; and
