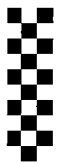

Re: Request for Determination of Public Convenience or Necessity for Wingtip located at 550 Montgomery St., Ground Floor

Dear Members of the Neighborhood Services and Safety Committee:

This firm represents On the Fly, Inc., *dba* Wingtip (“Wingtip”). Wingtip recently applied for the transfer of a Type-21 license (see application no. 535058) to its retail store located on the ground floor of 550 Montgomery St. (the “Store”).

We have been informed by the Department of Alcoholic Beverage Control (“ABC”) that a determination of public convenience or necessity by the Board of Supervisors is a condition to the ABC’s issuance of this license. On behalf of Wingtip, we respectfully request that the Board determine that the issuance of a Type-21 license to Wingtip will serve public convenience or necessity.

**I. Project Description.**

Since 2008, Wingtip has been selling high-end men’s clothing and accessories, including barware such as crystal wine decanters, pewter carafes, champagne flutes and crystal glassware. Screenshots from Wingtip’s website showing examples of the items it offers is attached hereto as **Exhibit A**. In September, 2012, Wingtip moved into its current location at 550 Montgomery St. As a complement to its existing offering, Wingtip desires to offer a high-end selection of small-batch bourbons, craft whiskeys, and single-malt scotches to its clientele.

The offering will be displayed in an 8’ x 20’ locked glass case, which will be located behind the security desk on the ground level. This security desk is staffed at all times during business hours. Business hours are Monday – Friday 10:00 a.m. to 7:00 p.m., and on Saturdays from 10:00 a.m. – 6:00 p.m. The Store is not open on Sundays.

**II. The Product Mix is Designed to Appeal only to Bourbon, Whiskey and Scotch aficionados.**

With price points starting at \$30 per bottle and ranging upward of \$3,000 per bottle, the product mix will be specifically tailored to discerning Bourbon, Whiskey and Scotch lovers who are looking for a unique or hard-to-find addition to their personal collection or a special gift for a colleague or friend. The selection is not designed to appeal to the casual drinker, nor is it designed to attract those looking to abuse alcohol.

**III. The issuance of a License to the Store will Not have a Detrimental Impact on the Surrounding Area.**

Because all bottles will be displayed in a locked glass case located behind the security desk which is staffed at all times during business hours, coupled with the price-points of the proposed offering and the fact that the Store is not open past 7:00 p.m., the issuance of the License will not pose a security risk to the community nor create any additional burdens on local law enforcement.

While the Store may be located in a census tract (0611.00) with “undue concentration” (as defined by Business & Professions Code § 23958.4), this is largely due to the fact that census tract 0611.00 is located in the heart of San Francisco’s Financial District, which has fewer residents than many other census tracts, and not because of an excessively high number of retail outlets in the census tract. Moreover, as a result of the methodology by which “undue concentration” is determined (i.e. the number of licenses vs. the population in the census tract), almost every census tract in California located in a heavily commercial/retail area with a low population density – such as census tract 0611.00 – has “undue concentration.” Therefore, Wingtip respectfully requests that the Board consider the fact that the Store is located in a census tract with a low population in the heart of San Francisco’s Financial District when addressing the issue of “undue concentration.”

**IV. The Sale of Alcohol at the Store will serve Public Convenience or Necessity.**


While there may be other stores that sell distilled spirits in the area, Wingtip’s offering will be unique in that the focus will be solely on high-end and difficult to locate small-batch bourbons, craft whiskeys, and single-malt scotches. This offering will provide its customers with the convenience of one-stop shopping and enable them to be able to purchase high-end barware, and accessories as well as the distilled spirits to complement these luxury products in the same Store. Wingtip is committed to being a good community partner, and will provide this product offering to its customers without negatively impacting the surrounding area.

**V. Conclusion.**

The issuance of a Type-21 license to the Store will enable Wingtip to provide its customers with the perfect complement to the luxury accessories it currently sells, by offering a high-end selection of distilled spirits that is currently not available in most stores the area. Wingtip is committed to providing this offering in a safe, responsible and secure manner, with minimal disruption to the surrounding neighborhood and no added burden to local law enforcement.

For these reasons, Wingtip respectfully requests that the Board determine that public convenience or necessity will be served by the issuance of a Type-21 license to the Store. Thank you in advance for your consideration.
