2 Resolution urging passage of ACA10, Assemblyman David Cogdill's  
3 educational revenue augmentation fund bill.

4  
5 WHEREAS, The 1990's educational revenue augmentation fund  
6 is obsolete and new strategic funding is needed to effectively  
7 support California's educational services without having local  
8 funds be siphoned away for state budgetary purposes; and,

9 WHEREAS, Since passage of the educational revenue  
10 augmentation fund (ERAF), nearly \$30 billion has been shifted  
11 away from local government to balance the state budget using  
12 ERAF as the vehicle for moving funds; and,

13 WHEREAS, Local property tax shifts designed to resolve  
14 state budget cuts have resulted in severely reduced funding for  
15 library services, recreation and park services and education;  
16 and,

17 WHEREAS, ACA10 will give voters a way to allow local  
18 property taxes to be used for local government services such as  
19 libraries, parks, and schools; and,

20 WHEREAS, Increasing levels of service required by and  
21 provided to the public, coupled with increased limitations on  
22 the ability for local governments to generate revenue, have  
23 demonstrated a great need for the fiscal relief provided by  
24 ACA10; and,




