2 APPROVING THE SAN FRANCISCO FEDERAL FISCAL YEAR 1999 REFUGEE COUNTY
3 PLAN AND AUTHORIZING THE PRIVATE INDUSTRY COUNCIL OF SAN FRANCISCO,
4 INC. TO ACCEPT AND EXPEND APPROXIMATELY \$1,170,012 OF FEDERAL REFUGEE
5 FUNDS IN LINE WITH THE REFUGEE COUNTY PLAN.

6 WHEREAS, The Private Industry Council of San Francisco, Inc. (PIC), by
7 authorization of this Board of Supervisors acts with the approval of the Department of
8 Human Services for the City and County of San Francisco in administering federal Refugee
9 funds awarded to San Francisco; and

10 WHEREAS, The Refugee Committee is in an advisory capacity to the PIC with
11 respect to those funds; and

12 WHEREAS, The staff of the PIC, in consultation with the Refugee Committee, has
13 prepared the 1999 Refugee County Plan as required by the State Department of Social
14 Services, and that the Refugee County Plan describes the uses of the refugee funds for the
15 Federal Fiscal Year (FFY) beginning October 1, 1999; and

16 WHEREAS, The State has issued preliminary allocations for Refugee Employment
17 Social Services (RESS) funds (\$300,937) and Targeted Assistance (TA) funds (\$869,075)
18 for a preliminary total of \$1,170,012 for services to refugees in San Francisco; now
19 therefore, be it

20 RESOLVED, That the Refugee County Plan for San Francisco is approved; and be it

21 FURTHER RESOLVED, That the Interim President of the PIC is authorized by the
22 Board of Supervisors to accept and expend approximately \$1,170,012 of federal refugee
23 funds from the State Department of Social Services in line with the Refugee County Plan;
24 and be it

25 FURTHER RESOLVED, That the PIC is authorized by the Board of Supervisors to
26 amend the Refugee County Plan as may be requested by the State Department of Social
27 Services or its designee.


