3 **Resolution extending for an additional 30 days the prescribed time within which the**  
4 **Planning Commission may render its decision on a proposed ordinance to amend the**  
5 **San Francisco Planning Code by creating section 608.15 to establish the Northeast**  
6 **Waterfront Special Sign District, creating Section 609.14 to address amortization of**  
7 **nonconforming signs in this District, amending Section 608 and Article 10, Appendix D,**  
8 **section 7 to be consistent with the Ordinance, amending the Zoning Map Section Map**  
9 **SSD-1 to show the boundaries of this District, and making findings of consistency with**  
10 **the General Plan and priority policies of Planning Code section 101.1.**

12 WHEREAS, Supervisor Aaron Peskin introduced legislation to amend the San  
13 Francisco Planning Code by creating section 608.15 to establish the Northeast Waterfront  
14 Special Sign District, creating Section 609.14 to address amortization of nonconforming signs  
15 in this District, amending Section 608 and Article 10, Appendix D, section 7 to be consistent  
16 with the Ordinance, amending the Zoning Map Section Map SSD-1 to show the boundaries of  
17 this District, and making findings of consistency with the General Plan and priority policies of  
18 Planning Code section 101.2, a copy of which is on file with the Clerk of the Board of  
19 Supervisors in File No. 031034; and

20 WHEREAS, On June 10, 2003, the Clerk of the Board of Supervisors transmitted a  
21 copy of the proposed legislation to the Planning Commission for public hearing pursuant to  
22 Planning Code Section 302(b); and,

23 WHEREAS, Planning Code Section 307.4(d)(3) requires the Planning Commission to  
24 render its decision on the proposed legislation within 90 days of the date of referral and  
25 provides that failure to act within the prescribed time shall constitute disapproval; and,

1           WHEREAS, Planning Code Section 306.4(d)(3) authorizes the Board of Supervisors to  
2 extend by resolution the prescribed time within which the Commission is to render its decision  
3 on legislation initiated by the Board; and

4           WHEREAS, The Board deems it appropriate in this instance to grant the Planning  
5 Commission an additional 30 days to review the proposed legislation and render its decision;  
6 now, therefore, be it

7           RESOLVED, That the Board hereby extends the prescribed time within which the  
8 Planning Commission may render its decision on the proposed legislation to amend the  
9 Planning Code for an additional 30 days from September 8, 2003.
