**Ordinance authorizing settlement of the lawsuit filed by Armin Abdollahvand against the City and County of San Francisco for \$50,000; the lawsuit was filed on August 27, 2019, in San Francisco Superior Court, Case No. CGC-19-578732; entitled Armin Abdollahvand v. City and County of San Francisco, et al.; the lawsuit involves an alleged personal injury in a rear-end automobile collision involving a City employee.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Armin Abdollahvand v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-19-578732 by the payment of \$50,000. The lawsuit involves an alleged personal injury in a rear-end automobile collision involving a City employee.

Section 2. The above-named action was filed in San Francisco Superior Court on August 27, 2019, and the following parties were named in the lawsuit: Armin Abdollahvand, Plaintiff; City and County of San Francisco and Todd A. Sucey, Defendants.
