APPROVING THE REQUEST OF REMOVING CONDITIONS IMPOSED ON THE CONDITIONAL ALCOHOLIC BEVERAGE LICENSE FOR McLEAN BREWERIES, INC., DBA MAGNOLIA PUB & BREWERY, LOCATED AT 1398 HAIGHT STREET, IN ACCORDANCE WITH SECTION 23803 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE WITH A CONDITION.

WHEREAS, David C. McLean owner of McLean Breweries, dba Magnolia Pub & Brewery is seeking the removal of Conditions Numbers 1, 3 and 6 imposed on his conditional alcoholic beverage control license located at 1398 Haight Street; and

WHEREAS, The Planning Department states that Conditions 1 and 3 cannot be changed without authorization by the City Planning Commission, and the Planning Department has no concern over the removal of Condition 6; and

WHEREAS, The San Francisco Police Department recommends the approval of removing the conditions imposed on the conditional alcoholic beverage control license with one condition; now, therefore, be it

RESOLVED, That in accordance with Section 23803 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines that the grounds which caused the imposition of Conditions Numbers 1, 3 and 6 no longer exist, hereby determines that the conditions imposed should be removed with the condition that the premise be allowed off-sale privilege of Micro-Brew Beer sold in containers no smaller than one gallon ("growler").


