

1 [Accept and Expend Grant - Bloomberg Philanthropies - Innovation Team Grant and
2 Amendment to the Annual Salary Ordinance for FYs 2025-2026 and 2026-2027 - \$7,000,000]

3 **Ordinance authorizing the Mayor’s Office to accept and expend a grant in the amount**
4 **of \$7,000,000 from Bloomberg Philanthropies to fund the Mayor’s Office of Innovation**
5 **from January 1, 2026, through December 31, 2028; approving the associated grant**
6 **agreement under Charter, Section 9.118; and amending Ordinance No. 120-25 (Annual**
7 **Salary Ordinance, File No. 250590 for Fiscal Years (FYs) 2025-2026 and 2026-2027) to**
8 **provide for the creation of four grant-funded full-time positions (4.0 FTE) in the Office**
9 **of the City Administrator, with one position in each of the following classes: Class 0931**
10 **(Manager III), Class 1053 (IS Business Analyst - Senior), Class 1054 (IS Business**
11 **Analyst - Principal), and Class 1043 (IS Engineer - Senior).**

20 Be it ordained by the People of the City and County of San Francisco:

21 **Section 1. Background.**

22 The Office of the Mayor has applied for and has been awarded a grant from Bloomberg
23 Philanthropies, in the amount of \$7,000,000 to cover the period from January 1, 2026, through
24 December 31, 2028, to expand the Mayor’s Office of Innovation. Bloomberg Philanthropies is
25 supporting the City and County of San Francisco, California in building a next-generation
innovation team (the Mayor’s Office of Innovation) that will serve as a catalyst for designing
and scaling solutions to the City’s most pressing challenges and offer a model and learnings

1 to other local governments tackling similar challenges. The Mayor’s Office of Innovation will
2 deliver for San Franciscans by leading critical projects that support the Mayor’s top priorities,
3 such as clean, safe streets and economic revitalization. The Mayor’s Office of Innovation will
4 bring valuable skillsets that are rarer in the City workforce, such as product management and
5 user centered design, to accelerate progress on these priorities.

6
7 **Section 2. Authorization to Accept and Expend Grant Funds; Approval of Grant**
8 **Agreement.**

9 (a) The Board of Supervisors hereby authorizes the Mayor’s Office to accept and
10 expend \$7,000,000 in grant funds from Bloomberg Philanthropies to expand the Mayor's
11 Office of Innovation, which will use data, digital tools, human-centered design, public-private
12 partnerships, and other innovative approaches to deliver outcomes and advance government
13 accountability and transparency for San Francisco residents, as generally set forth in the grant
14 application and grant budget and Grant Agreement, all of which are on file with the Clerk of
15 the Board of Supervisors in File No. 251226 and which are incorporated herein by reference.
16 The Mayor's Office of Innovation proposes to maximize use of available grant funds on
17 program expenditures by not including indirect costs in the grant budget, and indirect costs
18 are hereby waived. The grant requires the City to partially match the grant funds, either
19 through additional general fund sources or philanthropic fundraising, equal to at least
20 \$2,333,333, with one half secured by September 30, 2026 and the balance by September 30,
21 2027.

22 (b) The Board of Supervisors hereby approves the Grant Agreement pursuant to
23 Charter Section 9.118.
