3 **Ordinance authorizing settlement of the lawsuit filed by Stacey A. Lawrence against the**
4 **City and County of San Francisco for \$224,000; the lawsuit was filed on May 8, 2015, in**
5 **San Francisco Superior Court, Case No. CGC-14-542269; entitled Stacey A. Lawrence v.**
6 **City and County of San Francisco, et al.; the lawsuit involves alleged property damage**
7 **arising from the break of the Public Utilities Commission's water transmission pipeline**
8 **on 15th Avenue between West Portal Avenue and Wawona Street in San Francisco; and**
9 **appropriating \$224,000 from the Water Enterprise fund balance for such purpose.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Stacey A. Lawrence v. City and
14 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-542269 by
15 the payment of \$224,000. The lawsuit involves alleged property damage from the break of
16 the SFPUC's water transmission pipeline on 15th Avenue between West Portal Avenue and
17 Wawona Street in San Francisco.

18 Section 2. The above-named action was filed in San Francisco Superior Court on May
19 8, 2015, and the following parties were named in the lawsuit: Plaintiff: Stacey A. Lawrence,
20 Defendants: City and County of San Francisco, Precision Engineering, Inc.

21 Section 3. The Board herein appropriates \$224,000 from the Water Enterprise fund
22 balance for use by the San Francisco Public Utilities Commission for purposes of settling the
23 litigation.




