

1 [Accept and Expend Federal Funds – Fiscal Year 2006 Lead Hazard Reduction
2 Demonstration Grant Program]

4 **Resolution authorizing the Mayor of the City and County of San Francisco to accept**
5 **and expend a grant from the U.S. Department of Housing and Urban Development**
6 **for lead-based paint hazard reduction in a total amount not to exceed \$3,350,000,**
7 **which includes controller's costs of \$33,500**

8 WHEREAS, The U.S. Department of Housing and Urban Development (HUD) has
9 awarded a Fiscal Year 2006 Lead Hazard Control Grant to the City and County of San
10 Francisco (City) in the amount of \$3,350,000 (the Grant), for a period of not more than
11 thirty six months for the purpose of controlling lead based paint in eligible rental housing
12 units and homeowner occupied housing units constructed before 1978; and

13 WHEREAS, on February 8, 2007, the Director of the Mayor's Office of Housing entered
14 into an agreement with HUD to accept the Grant; and

16 WHEREAS, Under the Grant agreement HUD requires the City to submit its work
17 program and proposed budget within 60 days for HUD review and approval, and to
18 commence operation of the lead hazard reduction demonstration program funded by the
19 Grant no later than March 31st, 2005; and

20 WHEREAS, MOH has prepared an Expenditure Schedule for the use of the Grant on file
21 with the Clerk of the Board of Supervisors in File No. 070464, which is hereby
22 declared to be part of this resolution as if set forth fully herein; now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby authorizes the Director of MOH, on
24 behalf of the City, retroactively to accept and to expend the Grant from HUD; and, be it

FURTHER RESOLVED, That controller's costs of \$33,500 have been included in the expenditure schedule; and

FURTHER RESOLVED, That the Director of MOH is hereby authorized to submit documentation and certifications required by HUD on behalf of the City.
