3 **Ordinance authorizing settlement of the lawsuit filed by Damena Page against**
4 **the City and County of San Francisco and all allegations in related Government Claim**
5 **No. 25-00817 for \$75,000; the lawsuit was filed on June 23, 2023, in United States**
6 **District Court for the Northern District of California, Case No. 23-cv-03129; entitled**
7 **Damena Page v. City and County of San Francisco, et al.; the lawsuit and Government**
8 **Claim involve alleged civil rights violations.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Damena Page v. City and County of
13 San Francisco, et al., United States District Court for the Northern District of California, Case
14 No. 23-cv-03129, together with all allegations contained in Government Claim No. 25-00817,
15 by the payment of \$75,000. The lawsuit and Government Claim involve alleged civil rights
16 violations.

17 Section 2. The above-named action was filed in United States District Court for the
18 Northern District of California on June 23, 2023, and the following parties were named in the
19 lawsuit: Plaintiff Damena Page; Defendants City and County of San Francisco, Stephen
20 Tilton, San Francisco Sheriff's Department ("SFSD") Badge #1455, Jeffrey Ng, SFSD Badge
21 #2434, and Edwin Pliego, SFSD Badge #2380.
