11 WHEREAS, Upon the completion of a request for proposals process, the Airport  
12 Commission awarded International Terminal Food and Beverage Concession Lease No.  
13 16-0014 to the highest-ranking responsive and responsible proposer, Tastes On The Fly,  
14 San Francisco, LLC, by Airport Commission Resolution No. 16-0014 adopted January 19,  
15 2016; and

16 WHEREAS, International Terminal Food and Beverage Concession Lease No. 16-0014  
17 has a term of seven years with three options to extend of one year each for a pre-security  
18 concession and a term of ten years with two options to extend of one year each for two post-  
19 security concessions, and an initial Minimum Annual Guarantee of \$910,000; now, therefore,  
20 be it

21 RESOLVED, That this Board of Supervisors hereby approves International Terminal  
22 Food and Beverage Concession Lease No. 16-0014, a copy of which is on file with the Clerk  
23 of the Board in File No. 160447; and, be it

1           FURTHER RESOLVED, That within thirty days of the lease being fully executed by all  
2 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
3 inclusion into the official file.


