

1 [Estate of Zygmunt Arendt]

2 AUTHORIZING THE DEPARTMENT OF HUMAN SERVICES TO SUBMIT ITS PROPOSED
3 PLAN FOR THE ADMINISTRATION OF THE ARENDT ESTATE, THROUGH THE PUBLIC
4 ADMINISTRATOR, TO THE PROBATE COURT FOR APPROVAL.

6 WHEREAS, Mr. Zygmunt Arendt bequeathed his estate to the poor and needy people
7 of the City and County of San Francisco; and,

8 WHEREAS, Mr. Arendt's will requests that his estate be divided "sixty percent to the
9 poor and needy people and forty percent to the most needy seniors' and children's disabled
10 groups"; and,

11 WHEREAS, Mr. Arendt's will appoints as executors of the estate a team consisting of
12 the Mayor and the Board of Supervisors of the City and County of San Francisco; and,

13 WHEREAS, Mr. Arendt's will requests that this team oversee the interviewing and
14 evaluation of each person prior to providing assistance to that person; and,

15 WHEREAS, Mr. Arendt's will further requests that this team oversee the distribution of
16 the estate; and,

17 WHEREAS, The Public Administrator for the City and County of San Francisco has
18 been appointed to serve as the personal representative of the Mayor and Board of
19 Supervisors for the purpose of probating the estate; and,

20 WHEREAS, The Executive Director of the Department of Human Services (DHS) has
21 been designated as the City official responsible for managing the expenditures from the estate
22 consistent with the terms of the will and under oversight of the Mayor and the Board of
23 Supervisors; and

24 WHEREAS, The DHS Executive Director has developed a plan to establish a trust in
25 the name of the benefactor to be overseen by a committee of uncompensated trustees

1 nominated by the DHS Executive Director and confirmed by the Human Services
2 Commission; and

3 WHEREAS, The trustees would distribute the portion of the bequest designated for the
4 most needy seniors' and disabled children to organizations that serve those groups; and

5 WHEREAS, The portion intended to assist the poor and needy would be used for
6 special supportive services for indigent adults participating in self-sufficiency programs who
7 are otherwise ineligible for MediCal-funded services, such as dental, eye and medical care,
8 and other basic needs not funded through existing programs; and

9 WHEREAS, Such indigent adults participating in self-sufficiency programs will be
10 interviewed and evaluated prior to receiving assistance from this fund, in accordance with Mr.
11 Arendt's stipulation; and

12 WHEREAS, The DHS Executive Director's recommendations for expenditures from
13 the estate are consistent with the terms of Mr. Arendt's will, and will not supplant existing
14 funding; now, therefore, be it

15 RESOLVED, That Board of Supervisors approves the DHS Executive Director's
16 recommendations for expenditures from the Arendt estate; and be it

17 FURTHER RESOLVED, That the DHS Executive Director is authorized to submit,
18 through the Public Administrator, these recommendations to the Probate Court for approval.


