8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Lauren Jones v. City and County of
11 San Francisco, San Francisco Superior Court, Case No. CGC-21-589832 by the payment
12 of \$95,000. The lawsuit involves an employment dispute.
