

1 [Provide nutrition education in community settings to low-income families in San Francisco.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **accept retroactively and expend a grant in the amount of \$99,908 from the California**
5 **Department of Health Services (CDHS) to provide nutrition education in community**
6 **settings to low-income families in San Francisco and to enter into an agreement for the**
7 **use of these funds; for the period of January 1, 2004, to September 30, 2004.**

9 WHEREAS, SFDPH has applied for and been awarded a grant from CDHS in the
10 amount of \$99,908 to provide supportive services to newly housed formerly homeless people
11 with disabilities; and,

12 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
13 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
14 Board of Supervisors in File No. 040170, which is hereby declared to be a part of
15 this resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$7,050; and,

17 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
18 because the grant award letter was not received until after the grant start date; and,

19 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
20 may be placed automatically on consent agendas in committee, as they are usually
21 considered to be routine items, and this resolution authorizes the acceptance and expenditure
22 of grant funding; now, therefore, be it

23 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
24 grant in the amount of \$99,908 from CDHS; and, be it


