3 **Ordinance authorizing settlement of the lawsuit filed by Mary Tuimavave against the**  
4 **City and County of San Francisco for \$26,250; the lawsuit was filed on October 31,**  
5 **2023, in San Francisco Superior Court, Case No. CGC-23-610106; entitled Mary**  
6 **Tuimavave v. Gabia Konce, et al.; the lawsuit involves alleged personal injury on a City**  
7 **sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Mary Tuimavave v. Gabia Konce, et  
12 al., San Francisco Superior Court, Case No. CGC-23-610106 by the payment of \$26,250.  
13 The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 October 31, 2023, and the following parties were named in the lawsuit: Plaintiff Mary  
16 Tuimavave; Defendants Gabia Konce, City and County of San Francisco; Cross-Complainant  
17 City and County of San Francisco; Cross-Defendant Gabia Konce.
