8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled BRE Parc 55 Owner, LLC v. City and
11 County of San Francisco, San Francisco Superior Court, Case No. CGC-14-537160 by the
12 payment of \$431,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 February 4, 2014, and the following parties were named in the lawsuit: BRE Parc 55 Owner,
15 LLC, Plaintiff; City and County of San Francisco, Defendant.




