ORDINANCE NO.

1 [Specifying that revenues from littering citations issued by DPW environmental control officers  
2 go to DPW.]

3 **Ordinance amending Section 38 of the Police Code Article to specify that revenues**  
4 **from citations issued by DPW environmental control officers for littering shall be**  
5 **allocated to DPW and used to fund litter enforcement and abatement.**

9 Be it ordained by the People of the City and County of San Francisco:

10 The San Francisco Police Code is hereby amended by amending Section 38, to read  
11 as follows:

12 **SEC. 38. ENFORCEMENT OF LITTER LAWS; DESIGNATED OFFICERS AND**  
13 **EMPLOYEES.**

14 The classes of officers or employees of the City and County of San Francisco  
15 hereinbelow set forth may have the duty of enforcing those provisions of state law or the San  
16 Francisco Municipal Code which relate to the littering of private or public property, including,  
17 but not limited to, streets, sidewalks, parks, squares or recreation areas within said City and  
18 County, the removal or abatement of any such litter from said private or public property or the  
19 unauthorized use of litter receptacles. The City and County's share of revenues generated from  
20 citations written by Class 8280 Environmental Control Officers employed by the Department of Public  
21 Works may be expended exclusively by the Department of Public Works for the purpose of funding litter  
22 enforcement and abatement.
