8 WHEREAS, sixty-three percent of San Francisco's voters have already called on the  
9 Federal government to "bring the troops safely home now;" when they passed Proposition N  
10 in November of 2004; now, therefore, be it

11 RESOLVED, That the Board of Supervisors urge Representatives Nancy Pelosi and  
12 Tom Lantos to add their names to the list of Representatives sponsoring H.Con.Res.35,  
13 introduced by Representative Lynn Woolsey, asking for the President to: 1) develop and  
14 implement a plan to begin the immediate withdrawal of U.S. troops from Iraq; 2) develop and  
15 implement a plan for the reconstruction of Iraq's civil and economic infrastructure; 3) convene  
16 an emergency meeting of Iraq's leadership, Iraq's neighbors, the United Nations, and the Arab  
17 League to create an international peacekeeping force in Iraq and to replace U.S. military  
18 forces with Iraqi police and National Guard forces to ensure Iraq's security; and 4) take all  
19 necessary steps to provide the Iraqi people the opportunity to completely control their internal  
20 affairs; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors direct the clerk of the board to  
22 send a copy of this resolution to Representatives Nancy Pelosi and Tom Lantos.
