9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled DOE 1 and DOE 2 v. City and County  
12 of San Francisco, San Francisco Superior Court, Case No. CGC-21-589554 by the payment  
13 of \$120,000.00. The lawsuit involves an employment dispute.
