12 al.," US District Court No. C02-1844 MEJ on the terms of conditions specified in that certain
13 Settlement Agreement and Release of Claims on file with the Clerk of the Board (File No.
14 051654) ("Settlement Agreement"). Under the terms of the Settlement Agreement, the
15 San Francisco International Airport may make certain disability access improvements at the
16 San Francisco International Airport, and pay \$40,000 in damages, \$235,000 in attorney's
17 fees, and \$14,500 in costs.




