22	Section ?	Background, Findings, and Purpose.
23	(a) On F	ebruary 25, 2020, Mayor London Breed proclaimed a state of emergency in
24	response to the COVID-19 pandemic. On March 3, 2020, the Board of Supervisors concurre	
25	in the February	25 Proclamation.

(b) On March 16, 2020, to mitigate the spread of COVID-19, the Local Health Officer
issued Order No. C19-07, which has been amended and replaced by subsequent orders,
directing San Franciscans to "shelter in place" beginning on March 17, 2020. These orders,
which are now known as "stay-safer-at-home" orders, generally require individuals to stay in
their homes to the extent possible, and require businesses to cease or limit all non-essential
operations at physical locations in the City, with some limited exceptions. Over the course of
the COVID-19 pandemic, restrictions on the operations of different types of businesses in the
City have fluctuated, but unquestionably a large number of businesses, and many types of
businesses, have faced and continue to face severe restrictions.

(c) The COVID-19 outbreak has caused significant negative impacts on businesses in the City. While the exact course of the pandemic cannot be predicted, it is expected to continue to pose serious public health concerns in San Francisco for months to come, and will continue to have serious negative impacts on businesses during that time. This ordinance is intended to mitigate those impacts by (1) extending to either June 30, 2021 or

November 1, 2021, depending on the business's San Francisco gross receipts and when the business commenced business in the City, the deadline for most businesses to pay the business registration fee for the fiscal year ending June 30, 2022, and (2) temporarily suspending penalties for the late payment of certain weights and measures fees and point of sale station fees through November 1, 2021.

Section 2. Definitions.

For purposes of this ordinance, the following terms shall have the following meanings: "Applicable Fee" means any fee charged under Section 1.13-5 or Chapter 115 of the Administrative Code, that was billed by the Tax Collector on or after March 17, 2020, and on or before October 1, 2021.

1	"Business Registration Certificate" means a "registration certificate," as defined in
2	Section 852.2 of Article 12 of the Business and Tax Regulations Code.
3	"Business Registration Fee" means the tax imposed under Article 12 of the Business
4	and Tax Regulations Code.
5	"City" means the City and County of San Francisco.
6	"Combined Group" has the meaning described in Section 956.3 of Article 12-A-1 of the
7	Business and Tax Regulations Code.
8	"Newly Established Business" has the meaning set forth in Section 852.1 of Article 12
9	of the Business and Tax Regulations Code.
10	"Person" has the meaning set forth in Section 6.2-15 of Article 6 of the Business and
11	Tax Regulations Code.
12	"Registration Year" has the meaning set forth in Section 852.4 of Article 6 of the
13	Business and Tax Regulations Code.
14	"San Francisco Gross Receipts" has the meaning used in Section 855 of Article 12 of
15	the Business and Tax Regulations Code.
16	"Tax Collector" has the meaning set forth in Section 6.2-19 of Article 6 of the Business
17	and Tax Regulations Code.
18	
19	Section 3. Extension of Deadline to Pay Business Registration Fees.
20	(a) Business Registration Renewals. The deadline under Articles 6 and 12 of the
21	Business and Tax Regulations Code for a Person or Combined Group that commenced
22	business in the City before January 1, 2021, with a Business Registration Certificate for the
23	Registration Year ending June 30, 2021 to apply for renewal of its Business Registration
24	Certificate (or Business Registration Certificates, if a Combined Group) and pay the Business
25	Registration Fee for the Registration Year ending June 30, 2022 shall be extended from

1	May 31, 2021 to the following dates November 1, 2021, and no penalty shall be assessed if
2	such Person or Combined Group files and pays that Business Registration Fee by these
3	dates: November 1, 2021
4	(1) For a Person or Combined Group with \$25,000,000 or less in total combined
5	San Francisco Gross Receipts in calendar year 2020: November 1, 2021; and
6	(2) For a Person or Combined Group with more than \$25,000,000 in total
7	combined San Francisco Gross Receipts in calendar year 2020: June 30, 2021.
8	Business Registration Certificates issued for the Registration Year ending June 30, 2021,
9	shall continue to be valid through November 1, 2021 or June 30, 2021, as applicable, for all
10	purposes.
11	(b) New Businesses Without a Business Registration Certificate Commencing
12	Business On or After January 1, 2021 and Before July 1, 2021. For a Newly Established
13	Businesses commencing business in the City on or before June 30, 2021, that has a Business
14	Registration Certificate for the Registration Year ending June 30, 2021, the deadline to apply
15	for renewal of its Business Registration Certificate (or Business Registration Certificates, if a
16	Combined Group) and pay the Business Registration Fee for the Registration Year ending
17	June 30, 2022 shall be extended to November 1, 2021, and no penalty shall be assessed if
18	such Person or Combined Group files and pays that Business Registration Fee by
19	November 1, 2021. For a Newly Established Business commencing business in the City on or
20	before June 30, 2021, that does not yet have a Business Registration Certificate for the
21	Registration Year ending June 30, 2021, the deadline to pay the Business Registration Fee
22	for the Registration Year ending June 30, 2022 shall be extended to November 1, 2021, and
23	no penalty shall be assessed if such Newly Established Business pays that Business
24	Registration Fee by November 1, 2021.
25	

1	This subsection (b) shall not relieve a Newly Established Business from the requirement to
2	timely apply for a Business Registration Certificate (or Business Registration Certificates, if a
3	Combined Group) and timely pay the prorated Business Registration Fee for the Registration
4	Year ending June 30, 2021. A Newly Established Business subject to this subsection (b) that
5	applies for a Business Registration Certificate (or Business Registration Certificates, if a
6	Combined Group) and pays the prorated Business Registration Fee, plus any applicable
7	penalties and interest, for the Registration Year ending June 30, 2021, shall be issued a
8	Business Registration Certificate (or Business Registration Certificates, if a Combined Group)
9	for the Registration Year ending June 30, 2021, which shall continue to be valid through
10	November 1, 2021, for all purposes.

(c) New Businesses Commencing Business On or After July 1, 2021. For a Newly Established Businesses commencing business in the City on or after July 1, 2021, the deadline for payment of the Business Registration Fee for the Registration Year ending June 30, 2022 shall be extended to November 1, 2021, and no penalty shall be assessed if such Newly Established Business pays that Business Registration Fee by November 1, 2021. This subsection (c) shall not relieve a Newly Established Business from the requirement to timely apply for a Business Registration Certificate (or Business Registration Certificates, if a Combined Group) for the Registration Year ending June 30, 2022. A Newly Established Business subject to this subsection (c) shall not receive a Business Registration Certificate (or Business Registration Certificates, if a Combined Group) until it has paid its Business Registration Fee for the Registration Year ending June 30, 2022, but:

(1) all requirements in the San Francisco Municipal Code that a Business Registration Certificate be posted shall be waived for such Newly Established Business for all purposes through November 1, 2021; and

1	(2) such Newly Established Business shall receive a business account number
2	(or numbers, if a Combined Group) reflecting its registration with the Tax Collector, and shall
3	not be reflected as being delinquent in the records of the Tax Collector until
4	November 2, 2021, on account of not paying its Business Registration Fee for the Registration
5	Year ending June 30, 2022.
6	(d) A Newly Established Business that does not have a certificate of authority for the
7	collection of third-party taxes under Section 6.6-1 of Article 6 of the Business and Tax
8	Regulations Code, shall not be permitted to obtain such a certificate of authority until it has
9	paid its Business Registration Fee for the Registration Year or Years to which it is subject,
10	and shall not be permitted to engage in any business that requires it to collect the tax on
11	transient occupancy of hotel rooms in Article 7 of the Business and Tax Regulations Code or
12	the tax on occupancy of parking spaces in parking stations in Article 9 of the Business and
13	Tax Regulations Code without first paying its Business Registration Fee for the Registration
14	Year or Years to which it is subject.
15	(e) Persons or Combined Groups that cease business between July 1, 2021 and
16	November 1, 2021 shall still pay the Business Registration Fee for the Registration Year
17	ending June 30, 2022 and file any necessary forms to accompany that payment, except that
18	such payment deadline shall be extended to November 1, 2021 for:
19	(1) Persons or Combined Groups engaged in business in the City in calendar
20	year 2020 with \$25,000,000 or less in total combined San Francisco Gross Receipts in
21	calendar year 2020; and
22	(2) Newly Established Businesses commencing business in the City in calendar
23	<u>year 2021</u> .
24	

1	(f) The Tax Collector shall timely issue Business Registration Certificates to all
2	Persons that choose to pay the Business Registration Fee for the Registration Year ending
3	June 30, 2022 prior to November 1, 2021.
4	
5	Section 4. Temporary Penalty Suspension for Late Payment of Certain Fees; Refund
6	of Suspended Penalties.
7	(a) The penalties under Sections 1.13-5(h) and 115.5 of the Administrative Code shall
8	be suspended with respect to Applicable Fees through November 1, 2021. Penalties
9	suspended under this Section 4 shall recommence for Applicable Fees not paid by
10	November 1, 2021. Solely for purposes of calculating these penalties, the "billing date" under
11	Section 1.13-5(h), and "the last day of the term of registration" and "the original due date"
12	under Section 115.5, shall be deemed to be October 2, 2021.

(b) Persons who have paid the Tax Collector any penalties suspended under this Section 4 shall be allowed a refund of those penalties, without interest, upon written request to the Tax Collector within the later of (1) one year of payment of the penalty, or (2) December 31, 2021.

Section 5. Effect of Penalty Suspension.

Persons subject to the provisions of Section 1.13-5 and/or Chapter 115 of the Administrative Code shall comply with all of the requirements set forth in those provisions, except as provided in Section 4 of this Ordinance. However, persons that do not pay the Applicable Fees by their original due dates shall not be reflected as being delinquent in the records of the Office of the Treasurer and Tax Collector until November 2, 2021, and the Division of Weights and Measures, including the Sealer of Weights and Measures, shall not

1	withhold the issuance of any applicable certificate, license, or permit solely on the basis that		
2	an Applicable Fee was not paid by its original due date.		
3			
4	Section 6. Severability.		
5	If any section, subsection, sentence, clause, phrase, or word of this ordinance, or any		
6	application thereof to any person or circumstance, is held to be invalid or unconstitutional by a		
7	decision of a court of competent jurisdiction, such decision shall not affect the validity of the		
8	remaining portions or applications of this ordinance. The Board of Supervisors hereby		
9	declares that it would have passed this ordinance and each and every section, subsection,		
10	sentence, clause, phrase, and word not declared invalid or unconstitutional without regard to		
11	whether any other portion of this ordinance or application thereof would be subsequently		
12	declared invalid or unconstitutional.		
13			
14	Section 7. Effective Date. This ordinance shall become effective 30 days after		
15	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the		
16	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board		
17	of Supervisors overrides the Mayor's veto of the ordinance.
