

1 [Grant Agreement Amendment - Children’s Council of San Francisco - Early Care and
2 Education Integrated Services - \$376,052,445]

3 **Resolution approving a first amendment to the grant agreement between the City and**
4 **County of San Francisco and Children’s Council of San Francisco, for the provision of**
5 **Early Care and Education Integrated Services to support the City’s implementation of**
6 **the San Francisco Citywide Plan For Early Care and Education to increase the amount**
7 **by \$178,410,733 for a total grant amount of \$376,052,445 and to extend the grant period**
8 **by two years for a total period of July 1, 2017, through June 30, 2022.**

10 WHEREAS, The City and County of San Francisco, wishes to provide Early Care and
11 Education Integrated Services by delivering subsidy administration and resource and referral
12 services; and

13 WHEREAS, The Office of Early Care and Education, in partnership with the Human
14 Services Agency, conducted a Request for Proposals for these services in January 2017; and

15 WHEREAS, Children’s Council of San Francisco submitted a responsive and
16 responsible proposal and was awarded the grant for the total amount of \$197,641,712 in
17 February 2017 to provide services for the period from July 1, 2017, through June 30, 2020;
18 and

19 WHEREAS, A modification of the Children’s Council of San Francisco grant, to extend
20 the grant from July 1, 2017, through June 30, 2022, in the amount of \$178,410,733 resulting
21 in a new total amount of \$376,052,445 was requested in November 2019; and

22 WHEREAS, The Human Services Agency Commission approved this modification to
23 the Children’s Council of San Francisco grant at its meeting of November 21, 2019; now,
24 therefore, be it

1 RESOLVED, That the Board of Supervisors hereby approves the first amendment to
2 the grant agreement with Children’s Council of San Francisco to increase the amount by
3 \$178,410,733 for a total grant amount of \$376,052,445 and to extend the grant period by two
4 years for a total period of July 1, 2017, through June 30, 2022; and, be it

5 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
6 executed by all parties, the Human Services Agency shall provide the final grant agreement
7 amendment to the Clerk of the Board for inclusion into the official file.
