  2. No noise shall be audible beyond the area under control of the license.
  3. No wine shall be sold with an alcoholic content of great than 15% by volume except for "Dinner Wines" which have been aged two years or more and maintained in corked bottles.
  4. Wine shall not be sold in bottles or containers smaller than 500ml.
  5. The sale, service and consumption of powder alcohol or like non-liquid alcoholic beverage based product is prohibited
- It should be noted that on 05/28/15, I spoke with Mr. Michael Pollastro who agreed with the above recommended conditions.

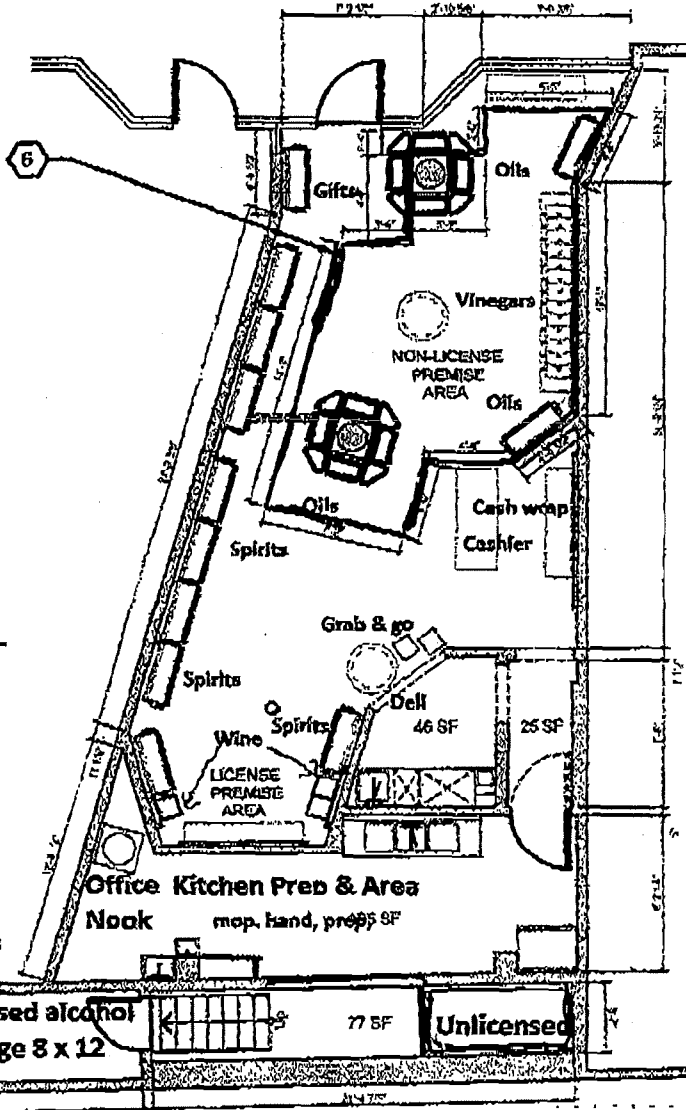
