3 **Ordinance authorizing settlement of the lawsuit filed by Golden Bear Insurance**  
4 **Company and Allied World Assurance Company against the City and County of San**  
5 **Francisco for \$1,611,913.13; the lawsuit was filed on March 11, 2025, in San Francisco**  
6 **Superior Court, Case No. CGC-25-623204; entitled ALLIED WORLD NATIONAL**  
7 **ASSURANCE COMPANY, and GOLDEN BEAR INSURANCE COMPANY v. City and**  
8 **County of San Francisco; the lawsuit involves alleged property and economic damages**  
9 **arising from the March 27, 2023, break of the SFPUC's water transmission pipeline at or**  
10 **near the intersection of Gough Street and Ellis Street.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle the action entitled **ALLIED WORLD NATIONAL**  
15 **ASSURANCE COMPANY, and GOLDEN BEAR INSURANCE COMPANY v. City and**  
16 **County of San Francisco**, San Francisco Superior Court, Case No. CGC-25-623204 by the  
17 payment of \$1,611,913.13. The lawsuit involves alleged property damages and economic  
18 losses arising from flooding.

19 Section 2. The above-named action was filed in San Francisco Superior Court on  
20 March 11, 2025, and the following parties were named in the lawsuit: Allied World National  
21 Assurance Company, Golden Bear Insurance Company and City and County of San  
22 Francisco.
