17 operator of a medical cannabis dispensary, for a one-year term ending August 31, 2017.

18       Kevin Reed, seat 11, succeeding Michelle Aldrich, term expired, must be an individual  
19 who uses cannabis for medicinal purposes and has at least two years of cannabis legalization  
20 advocacy experience, for a one-year term ending August 31, 2017.

21       Sara Payan, seat 12, succeeding herself, term expired, must be an individual who  
22 uses cannabis and has at least two years of cannabis legalization advocacy experience, for a  
23 one-year term ending August 31, 2017.

24       Duncan Talento Ley, seat 13, succeeding himself, term expired, must be an owner of  
25 a small business in San Francisco, for a one-year term ending August 31, 2017.

1           Thea Selby, seat 14, succeeding herself, term expired, must be an individual with  
2 experience working for, or on behalf of, the interests of businesses in San Francisco, for a  
3 one-year term ending August 31, 2017.

4           Jon Ballesteros, seat 15, succeeding herself, resigned, must be an individual with  
5 experience working to advance the tourism or hospitality industry in San Francisco, for the  
6 unexpired portion of a one-year term ending August 31, 2017.

7           Barbara Fugate, seat 16, succeeding herself, term expired, must be an individual who  
8 represents a neighborhood association, for a one-year term ending August 31, 2017.

9           Tom McElroy, seat 17, succeeding herself, term expired, must be an individual who  
10 represents a neighborhood association, for a one-year term ending August 31, 2017.

11           Laura Thomas, seat 18, succeeding herself, term expired, must be an individual with  
12 experience in public health advocacy focusing on drug policy, for a one-year term ending  
13 August 31, 2017.

15 working in the entertainment or nightlife industry, for a one-year term ending August 31, 2017.

16           Sarah Shrader, seat 21, succeeding herself, term expired, must be a public policy  
17 expert working for an organization focused on the formulation of good public policy, for a one-  
18 year term ending August 31, 2017.

19           Daisy Ozim, seat 22, succeeding herself, term expired, must be an individual  
20 between the ages of 21 and 30 at the time of appointment, for a two-year term ending August  
21 31, 2017.
