8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the action entitled "Mary
10 Allen, et al. v. City and County of San Francisco, et al.", San Francisco Superior, Court No.
11 CGC-10-504814 by the payment of \$40,000 in exchange for a dismissal with prejudice and a
12 waiver of any and all monetary sanctions.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 October 22, 2010, and the following parties were named in the lawsuit: Plaintiff Mary Allen;
15 Defendants City and County of San Francisco and San Francisco General Hospital Medical
16 Center.
