3	Resolution condemning the rescission of the Deferred Action for Childhood Arrivals
4	(DACA) Program and expressing continued support for all immigrants.
5	
6	WHEREAS, On June 15, 2012, former President Barack Obama signed the Deferred
7	Action for Childhood Arrivals (DACA), an executive action that protects nearly 800,000
8	undocumented young people from deportation, provides access to a Social Security number
9	and work authorization to undocumented young people; and
10	WHEREAS, On September 10, 2013, the Board of Supervisors passed a Resolution
11	"commending the Dream SF Deferred Action Grant Program and declaring September 4,
12	2013, as Deferred Action for Childhood Arrivals (DACA) Day in the City and County of San
13	Francisco", on file with the Clerk of the Board of Supervisors in File No. 130830, which is
14	hereby declared to be a part of this resolution as if set forth fully herein; and
15	WHEREAS, Immigrants contribute greatly to the social fabric of our community; and
16	WHEREAS, According to a study by the Center for American Progress, DACA
17	recipients contribute significantly to a robust economy through their attainment of higher levels
18	of education, increased wages, and large purchases, including homes; and
19	WHEREAS, Should DACA be repealed, the Center for American Progress estimates a
20	reduction by \$433.4 billion to the national Gross Domestic Product, and a study by the
21	Immigrant Legal Resource Center concludes that 685,195 young immigrants would become
22	unemployed, resulting in \$3.4 billion in both the loss of income to those employees as well as
23	costs to businesses for recruitment, hiring and training new staff; and
24	WHEREAS, The diverse business and technology community recognizes both the
25	value and contribution of DACA recipients to the economy of the United States and

1	acknowledges the negative impact of eliminating DACA as evidenced by the letter authored
2	by Facebook CEO Mark Zuckerberg and leaders in the field of technology, at least 72% of the
3	top 25 Fortune 500 companies count DACA recipients among their employees; and
4	WHEREAS, A study conducted by the Dream Resource Center of the UCLA Labor
5	Center found that 69% of immigrant youth did not have healthcare, leaving many of their
6	physical and mental health needs unattended; and
7	WHEREAS, During the 2016 Presidential campaign, then-candidate Trump repeatedly
8	promised to rescind DACA should he be elected; and
9	WHEREAS, On January 25, 2017, President Trump signed an executive order called
10	"Enhancing Public Safety in the Interior of the United States," which massively expanded the
11	category of priority deportees to all people who may have any grounds for deportation; and
12	WHEREAS, The San Francisco Board of Supervisors has on multiple occasions
13	reiterated their unequivocal support of the immigrant community, including most recently the
14	Resolution approved on February 7, 2017, to support California Senate Bill 54 (SB 54), the
15	California Values Act, introduced by Senate President Pro Tem Kevin De León to limit and
16	disentangle state and local resources from immigration enforcement and require state
17	agencies to review their confidentiality policies that protect all California residents, regardless
18	of immigration status, on file with the Clerk of the Board of Supervisors in File No. 170133,
19	which is hereby declared to be a part of this resolution as if set forth fully herein; and
20	WHEREAS, On September 5, 2017, Attorney General Jeff Sessions announced the
21	rescission of the DACA program; now, therefore, be it
22	RESOLVED, The Board of Supervisors affirms its support for the estimated 11 million
23	undocumented immigrants who live in the United States; and, be it

1	FURTHER RESOLVED, The Board of Supervisors will hold accountable municipal
2	public agencies that violate sanctuary laws if they facilitate, identify, report, or turn over
3	anyone to federal immigration enforcement agencies; and, be it
4	FURTHER RESOLVED, The City and County of San Francisco will continue to
5	determine the best practices to safeguard the personal information of its residents; and, be it
6	FURTHER RESOLVED, The City and County of San Francisco will strongly urge any
7	entity receiving city funding to internally craft safety plans to institutionalize polices that protect
8	immigrants that are staff, receive services, and provide training and education to frontline staff
9	on applicable laws and rights relevant to the immigrant community; and, be it
10	FURTHER RESOLVED, The Board of Supervisors requests the Department of Public
11	Health and other appropriate agencies to provide immediately access to mental health
12	support services directed to all residents impacted by the DACA decision; and, be it
13	FURTHER RESOLVED, The City and County of San Francisco will send a letter to the
14	federal government, including U.S. Attorney General Jeff Sessions, U.S. Citizenship and
15	Immigration Services, and U.S. Immigration and Customs Enforcement, and Congressional
16	representatives to condemn the rescission of the DACA program.
