5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code and the  
6 San Francisco Traffic Code, the following regulations governing the movement of vehicles are  
7 hereby enacted or rescinded as designated below:

8 MULTIPLE LEFT TURN LANES – ESTABLISH

9 Front Street, northbound, at Pine Street (mandatory left turn from two left lanes)

10 NO RIGHT TURNS, 6 AM - 9 AM, MONDAY THROUGH FRIDAY, EXCEPT TAXIS -

11 ESTABLISH

12 Marina Boulevard, eastbound, at Baker Street

13 TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

14 Drumm Street, east side, from Market Street to 70 feet northerly (70-foot zone)

15 Front Street, west side, from Market Street to 22 feet northerly (22-foot zone at meter #1)

16 King Street, north side, from 7th Street to 310 feet westerly (310-foot zone)

17 TOW-AWAY, NO STOPPING, 3 PM - 6 PM, MONDAY THROUGH FRIDAY - RESCIND

18 TOW-AWAY, NO STOPPING, 7 AM - 9 AM AND 3 PM - 7 PM, MONDAY THROUGH

19 FRIDAY - ESTABLISH

20 Front Street, east side, from Pine Street to 86 feet southerly (86-foot zone)

21 Front Street, west side, between Market and Pine Streets
